### Program

Program offered is

#### **Bachelor of Architecture. (B.Arch.)**

Approved by Council of Architecture (CoA) with institute code MH89. Affiliated to University of Mumbai with affiliation code 1071. Approved intake is 40 plus additional 4 seats reserved for EWS candidates.

### Extra-Curricular

### Curriculum

Five-year B.Arch. degree course with one semester professional training in Architects office.

Academics follows syllabus, examination structure and criterion of University of Mumbai and guidelines by CoA. **Studio and open learning culture is a soul of academics here.**

**Admissions : Eligibility** - Admission to First year of B.Arch. Program The eligibility for admission to 1st year of B.Arch. Degree program for the academic session 2024-2025 shall be as per CoA (Minimum Standards of Architectural Education) Regulations, 2020. The eligibility in terms of Regulations, 2020 is as under: \*No candidate shall be admitted to architecture course unless he has passed an examination at the end of the 10+2 scheme of examination with at least 50 per cent. Aggregate marks in Physics, Chemistry and Mathematics and at least 50 per cent. marks in aggregate of the 10+2 level examination or passed 10+3 Diploma Examination with Mathematics as compulsory subject with at least 50 per cent. marks in aggregate. (\*proposal for amendment in above Eligibility Criteria has been submitted for approval of the Central Government. The revision in eligibility, if any, shall be notified upon approval).

**Admission Process** : Admission process will be as per ARA (Admission Regulating Authority) Maharashtra. **DTE code of VCAAD is 3483** However, we are starting preparatory sessions and workshops for academic year 2024-25 from July 2024 after filling up expression of interest in admission application form and an interview of an aspirant candidate.

### Fees

Tuition and development fees will be as approved by FRA (Fees Regulating Authority) Maharashtra.

Other fees Hostel Mess and any other fee is indeed reasonable.

Fee structure will be explained during admission counselling /campus visit /after formal enquiry.
